**Application for Membership**

As a member of the Chittenango Rod & Gun Club, you must work to support the best interests of the club and abide by its by-laws. Anyone not following posted range rules and/or deliberately causing damage to the club or range can be expelled from the club for just cause, and forfeits all dues paid.

Meetings are held on the first Thursday of every month. Members should attend a minimum of three meetings a year after acceptance into the club. All correspondence and information will be either done through e mail or our website. The club website address is [www.chittenangorodandgun.com](http://www.chittenangorodandgun.com).

The Chittenango Rod & Gun Club has a 100 yard rifle range and a 25 yard handgun range. The range is open from 9:00 AM until sundown unless we have special events scheduled, in which case you will be notified by e mail that the range will be closed. We also have a Trap Field that we operate in the spring, summer and fall based on shooter interest. We have a very nice 30 target archery course that we hold four or five shoots a year on. Members are encouraged to come and participate if you are a bow hunter or just shoot target. Lastly, in January, February, March and April we have a Black Powder League. Every week we shoot whatever type of Black Powder rifle you like towards bragging rights and prizes at the end of the league.

From time to time we are forced to work on the club building and grounds. Work parties include set up of targets for the Archery Shoots, cooking at the shoots, mowing lawn, building maintenance and grounds improvement. As a member you should be willing to participate in a couple of these work parties a year.

All dues are to be paid as of January 1 yearly. Any person that allows his/her account to go unpaid after the end of January could be asked to reapply for membership, if we are not over our membership quota.

Reasons for denial of membership include but are not limited to; 1) We are over our predetermined membership quota. 2) No member sponsor. 3) Poor reference check
